2019 ACEC Bipartisan Accomplishments

Ohio

Secured an increase in funding for transportation through HB 62 equating to \$865 million in statewide revenue.

Defeated a proposal to reduce the Small Business Income Deduction through GRF Budget Bill, HB 166.

Pursued regulation of indemnification clauses in public contracts with the introduction of HB 159.

Advocated to establish a payment assurance program for registered design professionals with the introduction of SB 136.

ACEC Ohio continues to monitor occupational licensure bills impacting professional engineers and surveyors.

National

Increased funding for most infrastructure accounts in year-end spending package fully funding highway, transit and aviation.

Secured the repeal of \$7.6 billion highway funding rescission, releasing \$336 million to ODOT.

Advocated for clean energy and environmental spending approved by Congress including \$208 million to EPA.

Extended section 179D energy building tax deduction and Section 45 renewable energy incentives.

Secured the repeal of the health insurance tax on small firm plans and "Cadillac tax" on high cost plans.
